

Tickets to BookCon and the *Wonder Woman*TM Screening with Leigh Bardugo and Fans OFFICIAL RULES

IMPORTANT: Please read these Official Rules before entering the Tickets to BookCon and the *Wonder Woman*TM Screening with Leigh Bardugo and Fans (the “Sweepstakes”), presented by Penguin Random House LLC (“Sponsor”).
